## WaterChek – Microbiology Programme

Global Proficiency's **WaterChek Microbiology** programme has been designed as a multi-purpose scheme providing test verification across a wide range of water sources and microbiological tests. These are provided as a two-sample set of freeze-dried vials and can be despatched to most destinations worldwide. There have been some challenges more recently due to Covid restrictions, however we continue to work closely with labs and freight providers.

The range of water types offered include **Potable Water, Receiving Water, Effluent Water, Pool Water and Sea Water.**

- **The Potable Water category (WMP)** includes a full suite of tests and is offered 6 times per year (Round 2, 4, 6, 8, 10, 12). Rounds 4 & 8 include the additional test *Pseudomonas aeruginosa*.
- **Potable Water category (WMQ)** offers Presence/Absence testing for Total coliforms and *E. coli* only, utilising enzyme substrate technology and is offered 4 times per year (Round 3, 5, 7 & 9).
- **Receiving (Recreational) Water (WMR)** includes a full suite of tests and is offered 3 times per year (Round 3, 7 & 9).
- **Effluent Water (WME)** includes a full suite of tests and is offered 3 times per year (Round 5, 8 & 10).
- **Pool Water (WML)** includes a full suite of tests and is offered 4 times per year (Round 2, 6, 8 & 11).
- **Sea (Marine) Water (WMS)** includes a full suite of tests and is offered twice per year (Round 4, & 10). This also includes the option of a separate sample set (**WMV**) for those labs testing Enterococci via enzyme substrate technology.

Please note that for all Water Micro testing the Membrane Filtration (MF cfu/100mL) and Most Probable Number (MPN/100mL) tests are assessed separately.

Certified reference material certificates contain values that are certified—which means they have the highest level of confidence that the stated value, and the associated uncertainty, are correct. The uncertainty contains all known variables that can contribute to the range within which the “true” value is likely to lie.

Did you know that not all values that accompany a certified reference material are certified?

The certificate should clearly state which values are certified and which are not. In many cases, only a few of the values provided are certified. It's up to the user to be aware of the difference and that it may affect the fitness-for-purpose of the material purchased.
